1. Payment terms are 1% 10th for payment in full, net EOM, unless stated otherwise on each invoice. If the account becomes past due or exceeds credit limit, orders may be subject to hold until the account is current. A 1.5% service charge on past due balances will be charged monthly. Billing cycle is through the end of the month.
2. A \$30 handling charge is assessed to checks returned uncollected.
3. The foregoing statements and accompanying financial statements are correct and were provided to induce GBS Building Supply – US LBM, LLC, hereinafter referred to as GBS, to extend open account credit to the Applicant. The Applicant agrees that a faxed copy of this signed credit application shall be enforceable as an original.

5. Advance notice will be given to GBS of any change in the business structure. In other words, incorporation, changed ownership, etc. Notice will be given by certified or registered letter and acknowledged by return receipt.
6. Credit policies are subject to change at the discretion of the credit department. Upon acceptance of this application, and the issuance of an open line of credit, the Applicant agrees to abide by such credit policies of GBS as are in effect from time to time.

This guaranty shall remain in full force and effect until terminated by the receipt of written notice from the Guarantor to GBS, however any such termination shall not in any manner affect the Guarantor’s liability as to any indebtedness contracted for prior to receipt of such notice by GBS, nor the liability of any other Guarantor. Each Guarantor hereby waives any claim, right or remedy, which such Guarantor may now have or hereafter acquire against GBS that arises hereunder and/or from performance in any claim, right, or remedy of GBS against the Applicant or any security which GBS now has or hereafter acquires, whether or not such claim, right, or remedy arises in equity, under contract, by statute, under common law, or otherwise. The undersigned further agree to pay all expenses and costs of collection, including court costs and reasonable attorney’s fees of 20% of the balance due hereunder, which may be paid or incurred by GBS in the collection of any amounts owed by the Applicant or enforcing this guaranty. The Applicant agrees that a faxed copy of this personal guaranty shall be enforceable as an original.
